LOGIN BY BIDDER:-

- a) A bidder desires of taking part in a tender invited by a State Government Office/PSU/Autonomous body/Local body/PRIs, etc. shall login e-procurement portal of the Government of West Bengal http://wbtenders.gov.in using his login ID and password.
- b) He will select the tender to bid and initiate payment of pre-defined EMD/Tender Fees for that tender by selecting from either of the following payment modes: -
- I) Net banking (any of the banks listed in the ICICI Bank Payment Gateway) in case of payment through ICICI Bank payment Gateway.
- II) Net banking (any of the banks listed in the ICICI Bank Payment Gateway) in case of Payment through ICICI Bank payment Gateway.

3. PAYMENT PROCEDURE: -

- a) Payment by Net Banking (any enlisted bank) through ICICI Bank Payment Gateway.
- (i) On selection of Net Banking as the payment mode, the bidder will be directed to ICICI Bank Payment Gateway webpage (along with a string containing a Unique ID) where he will select the Bank through which he wants to do the transaction.
- (ii) Bidder will make the payment after entering his Unique ID and password of the bank to process the transaction.
- (iii) Bidder will receive a confirmation message regarding success/failure of the transaction.
- (iv) If the transaction is successful, the amount paid by the bidder will get credited in the respective Pooling account of the State Government/PSU/Autonomous body/Local body/PRIs etc. maintained with the Focal Point Branch of ICICI Bank at R. N. Mukherjee Road, Kolkata for collection of EMD/Tender Fees.
- (v) If the transaction is failure, the bidder will again try for payment by going back to the first step.
- b) Payment through RTGS/NEFT
- (i) On selection of RTGS/NEFT as the payment mode, the e-procurement portal will show a prefilled challan having details to process RTGS/NEFT transaction.
- (ii) The bidder will print the challan and use the prefilled information to make RTGS/NEFT payment using his/her bank account.
- (iii) Once payment is made, the bidder will come back to the e-procurement portal after expiry of a reasonable time to enable the RTGS/NEFT process to complete, in order to verify the payment made and continue the bidding process.

- (iv) If verification is successful, the fund will get credited to the respective pooling Account of the State Government/PSU/Autonomous Body/Local Body etc. maintained with the focal point branch of ICICI Bank at R.N. Mukherjee Road, Kolkata for collection of EMD/Tender Fees.
- (v) Hereafter, the bidder will go to e-procurement portal for submission of the bid.

4. Refund/ Settlement Process:

(i) After opening of the bids and technical evaluation of the same by the tender inviting authority through electronic processing in the e-payment portal of the State Government, the tender inviting committee will declare the status of the bids as successful or unsuccessful which will be made available, along with the details of unsuccessful bidders to the ICICI Bank by the E-procurement portal through web services.

- (ii) On receipt of the information from the e-procurement portal, the bank will refund through an automated process, the EMD of the bidders disqualified at the technical evaluation to the respective bidder's bank account from which they made payment transaction. Such refund will take place within T+2 bank working days where T will mean the date on which information on rejection of bid is uploaded to the e-procurement portal by the tender inviting authority.
- (iii) Once the financial bid evaluation is electronically processed in the e-procurement portal, EMD of the technically qualified bidders other than that of L1 and L2 bidders will be refunded through an automated process to the respective bidder's bank account from which they made the payment transaction. Such refund will take place within T+2 bank working days where T will mean the date on which information on rejection of bid is uploaded to the e-procurement portal by the tender inviting authority. However, L2 bidder should not be rejected till the LO-1 process is successful.
- (iv) If the L1 bidder accept the LO-l and the same is processed electronically in the e-procurement portal, EMD of the L2 bidder will be refunded through an automated process to his/her bank account from which he/she made the payment transaction. Such refund will take place within T+2 bank working days where T will mean the date on which information on Award of contract (AOC) to the L1 bidder is uploaded to the e-procurement portal by the tender inviting authority
- (v) As soon as the L1 bidder is awarded the contract (AOC), and the same is processed electronically in the e-procurement portal.
- a) EMD of the L1 bidder of the tenders of the state Govt. officers will automatically get transferred from the Pooling Account to the 'state Govt. Deposit Head 8443-00-103-001-07, through GRIPS along with the bank particulars of the L1 bidders.

- (viii) All refunds will be made mandatorily to the bank account from which the payment of EMD and tender fees (if any) were initiated.

4. Performance security:

- (i) Within 15 (fifteen) days from the date of issue of notification of award by the purchaser, the successful bidders shall furnish performance security for an amount equal to @3% of the tendered value. The performance security shall be retained up to 6 (six) months after the date of completion of all contractual obligations by the contractor.
- (ii) The performance security shall be deposited in Indian Rupees to the State Government through Bank Guaranty. No other forms of Deposit can/will be entertained.
- (iii) In the event of any failure/default of the bidder with or without quantifiable loss to the purchaser, the amount of the performance security is liable to be forfeited by the purchaser.
- (iv) In the event of any amendment issued to the contract, the bidder shall, within 21(twenty-one) days of issue of the amendment, furnish the corresponding amendment to the performance security (as necessary), rendering the same valid in all respect in terms of the contract, as amended.

- 3. Rate(s) to be quoted against each specified item as mentioned in the financial bid (BOQ) Form. The price quoted in base rate & should be inclusive of all incidental charges excluding GST.
- 4. Sample of items to be submitted by L1, L2, & L3 bidders before uploading of AOC (Award of Contract) if asked. A post bid meeting to be convened before financial bid evaluation.
- 5. The unsuccessful bidder(s) will be received their earnest money back in time.
- 6. The earnest money will be forfeited if the bidder(s) withdraw(s) the tender after opening of bids.
- 7. The security deposit of the successful selected bidder may be forfeited for failure to supply within specified time and/or for supplying unsatisfactory articles in quantity and quality.
